**Vesicular Stomatitis (VS) Outbreak:**

Janice Kall linked a webinar in her Prez Sez that has really good info about the outbreak  
Janice reviewed recommendations by USEF

If a horse arrives on the facility and it is discovered that a horse has VS, all the horses would have to be quarantined on site. So, we are not able to hold shows currently.

Sherry-she interpreted it as a case by case basis in regards to staying on the grounds, they might have to go home and quarantine at their home

Current numbers from 6/6/23 now include Orange County  
25 confirmed and 35 suspected cases, 8 new confirmed, 3 more suspected

Since the start 62 animals affected, 19 confirmed and 23 suspect in San Diego (42 total)

Janice-historically VS crosses into the US about every 10 years

VS outbreak started around May 17<sup>th</sup>

Since we are not doing shows, we also are not having any income come in. We are open to other fundraiser ideas

North County Equestrian Center is closed to horses in/out, Poway Equestrian Center is still closed but maybe open

Kyla White-VS is spread by flies and gnats

Emily Bernard-she had one horse get VS, this horse never leaves her property. Her horse has now recovered. She has 7 horses on her property, it did not spread to them, horses on nearby properties also did not get it or have it.
