Jim said that Harry would consider some holding pens across the street. Yesterday, Jim had a meeting with the storm inspection personwith no findings. Jim said that there is extensive damage under the bleachers. It will require a lot of work. The Rodeo volunteers will put the blocking on the top 5 rows, but we need some volunteers down at the bleachers. It will take a lot of PVRA and Rodeo labor to fix the bleachers. Jim says we need to have safe access. This weekend, Dennis will be holding a work party to dig out footing pylons. Jim dug out with the backhoe about a foot. People have to be careful with shovels to not damage the metal. Jost will send out an email blast on the work party this weekend.

Humane Society Fire Evacuation Site info. Nancy followed up - No Update.

Sign: Jim said that the work that was turned in last year was lost. Jim has to recreate and turn it in again. He wants to pour the concrete at the same time as the concrete for the Skybox.
