TRAINER’S AGREEMENT

1. Trainers (including Pony Club-authorized trainers) must hold a riding PVRA membership.
2. Trainers must (i) maintain liability insurance coverage with limits of one million dollars per occurrence and two million dollars aggregate, and (ii) name PVRA as an additional insured on all such insurance policies, and (iii) ensure that current proof of insurance is on file with the PVRA Board of Directors prior to commencing any training activity at the PVRA grounds, and at all times during such training activities. Trainers agree that they will not conduct any training activities on the PVRA grounds until they have obtained and provided evidence of such insurance to PVRA. All training is automatically suspended if there is any lapse of insurance coverage. Trainers agree that if their insurance is canceled or suspended, or if prior to the expiration of the previous insurance policy they fail without good cause to provide PVRA with proof of current insurance, they shall pay PVRA \$1,500.00, plus \$1,500.00 for each other year or partial year they trained without insurance, to reinstate their training rights on the PVRA grounds, unless prior to such expiration they have provided PVRA with written notice of their intention to suspend their training activities at the PVRA grounds. Notice will be published in Horse Tales regarding any trainer whose privileges have been canceled.
3. Trainers are expected to conduct themselves in a professional, courteous and cooperative manner. Trainers and students agree to cooperate with PVRA members regarding the use of the PVRA grounds. Members shall be entitled to use other portions of the PVRA grounds during training; lessons do not preempt open riding. The undersigned trainer represents that he/she has medical insurance covering trainer for any injuries such trainer may sustain on the PVRA grounds and agrees to maintain such insurance at all times while training at the PVRA grounds.
4. Trainers are responsible for watering the area in which they are working to prevent a dust problem, regardless of the number of horses. It is acceptable for someone who is authorized by the board in operating the water truck to water on the trainer’s behalf. Trainers may contact the PVRA board or the board member of the month to connect with someone who is authorized to drive the water truck. All watering must be documented in the water truck logbook.
5. Trainers are required to collect and pay to PVRA a \$20 haul in fee from each non-PVRA member for each lesson conducted on the PVRA grounds.
6. Any trainer who violates the terms of this Agreement or the PVRA’s rules, including its Code of Conduct, shall be subject to discipline by the PVRA Board, which may include the revocation or suspension of membership and/or training rights at the PVRA grounds.
7. Trainers should bring to the attention of the Board of Directors any part of the grounds that are unsafe or in disrepair.

I hereby agree to abide by the above stated terms in addition to the PVRA Bylaws in order to retain privileges to train at PVRA. I agree that failure to do so may result in disciplinary action by the PVRA Board of Directors.
