Directions/Parking: From I-15: Exit Camino Del Norte and Proceed East until it turns into Twin Peaks at the Poway City Limits. Stay on Twin Peaks and continue past Midland to Tierra Bonita. Turn Right. PVRA is two blocks down Tierra Bonita on the Right Side. **From Highway 67:** Take Poway Road West to Espola and Turn Right. Turn Left on Twin Peaks. Turn Left on Tierra Bonita. PVRA is two blocks down on the Right. 14336 Tierra Bonita Rd, Poway 92064

Entries: Entries Must Be Mailed. Email Entries Will Be Accepted, but Must Follow with a mailed Entry Form including Payment. Entries must be received by August 22nd.

We are taking additional Covid-19 precautions to provide safety for everyone participating. Each Competitor must sign the Covid-19 Rules for Participation at the Summer Two WE Show. Steps will be taken to ensure the safety of our Judge and Scribe, Scorer, Office personnel, etc. Masks Will Be Required whenever you are within 6 feet of any person outside of your household. Each Rider is allowed only one additional person, whether that person is a Coach, Groom, Tacking Assistant or a member of your family. We will ask everyone to abide by these rules to keep us all safe.

Opening Date: August 5, 2020. Closing Date: August 17, 2020. Email Entries will be accepted until 9 pm on August 17, 2020. Closing Date will either be when the show is full or August 17th, whichever comes first. This Show will Close when Full.

Licensing This is a B-Rated Working Equitation competition licensed by WE United. That means points earned at these events will count toward your **2020 Year End Awards** and **Lifetime Rider Medals!**

Format of the Show: One day

Dressage tests will start promptly at 8:00 am, followed by Ease of Handling, then Speed. Due to the time constraints of a one-day show, we will only be accepting 20 entries, so please don't delay if you would like to enter! Grounds will open at 6:30 am.

Prizes

Ribbons 1st – 6th for each trial. Prizes for First.

Ribbons and prizes for overall winners in each division (combining points earned in all trials).

Note: All classes will be run as Open classes unless there are sufficient entries to justify splitting into divisions. A class will be split into Open/Amateur/Youth divisions provided there will still be at least three or more entries in each of the split classes. In the case of a split, ribbons will be awarded to each of the split classes. There will be a Young Horse Class for 4 and 5 year old horses in their first year of competition.

Entry Fees: Level 1 (Intro) = \$95 per entry.

Level 2 (Novice A) thru Level 6 (Advanced) = \$135 per entry.

State Drug Fee (\$8) + Grounds Fee (\$10) + WE United Starter Fee (\$2) = Total \$20 per entry (mandatory).

WE United Non-Member Fee = \$15 per WE United non-member.

Entry fee covers all trials offered at each level. Riders participating hors concours (H/C means riding for scores but not placement in the ribbons), pay the same entry fee, grounds fee and Drug Fee, but not the \$15 Non-Member fee

Stabling: **NO STABLING** is available on site.

Option for Those New to the Sport: We offer riders the opportunity to participate in this event as "H/C". H/C Riders can have a coach, on foot, with them in the competition arena throughout their rides. The coach is available to assist both verbally (providing instructions / suggestions) and physically (assisting with the gate, etc.) to help ensure that both horse and rider have a positive experience with the sport. H/C riders are participating for schooling purposes only (hors concours); they are not competing for awards/points.

Rules

The competitions will use the *United States Rules for Working Equitation Version 3.1*. Please make sure you have a copy of the current rules. They can be found on www.WEUnited.us -- go to the link for "Rules & Dressage Tests".

All horses must be registered with WE United. Lifetime Horse Recording with WE United is free! Go to: <https://goo.gl/forms/Hjn40NAe81aT2HRL2> to register your horse.

Although membership in WE United is not required to compete at these shows, we strongly encourage all participants to join the National organization. Your \$25 annual membership fee helps support the continued development of the sport in the United States and helps fund the Performance Awards Programs, Judge and Technical Delegate Trainings, website, and outreach programs the organization offers. Join online at www.WEUnited.us. For riders' scores at a competition to count toward performance awards the riders must be a member within 30 days after the conclusion of the show. Anyone who is not a current member of WE United must pay a \$15 non-member fee to compete. Riders schooling hors concours (H/C) are exempt from this non-member fee, as they are not competing.

*****Use of helmets is required for all competitors under 18 whenever they are mounted*****

Helmets are encouraged for EOH and Speed events.

Liability Release

All riding competitors, coaches and trainers will be required to sign the liability release on the entry form before being allowed to compete. Those entering online will sign the release when they check in at the show office, unless the scanned document includes all signatures. Those mailing their entry in should sign the release on the entry form.

Entry Agreement By entering a Poway Valley Riders Association and WE United Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the local rules of the competition. I agree to be bound by the Rules of Poway Valley Riders Association and WE United. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, Poway Valley Riders Association and WE United, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the competition may use or assign photographs, videos, audios, or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation.

Release, Assumption of Risk, Waiver, and Indemnification: This document waives important legal rights. Read it carefully before signing. I AGREE in consideration for my participation in a Poway Valley Riders Association and WE United Competition to the following: I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, handler, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("Harm"). I AGREE to release Poway Valley Riders Association, its staff and volunteers from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the Competition. I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Competition. I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) Poway Valley Riders Association and WE United, its staff and volunteers and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Competition. I have read the Rules about protective equipment, and understand that I am strongly encouraged to wear protective equipment, while WARNING that no protective equipment can guard against all injuries. If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to assume all of the obligations of this Release on the child's behalf. All junior exhibitors are required to wear protective headgear. I AGREE that "Poway Valley Riders Association and WE United", "its staff and volunteers" as used above includes all of the officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations. I represent that I have the requisite training, coaching and abilities to safely compete in this competition.

Covid-19 Rules for Participation at the August 23, 2020
PVRA Summer Two B-Rated Working Equitation Show

Modifications for safety, precautions and rules for physical distancing

1. Please consider this form as written instructions for Covid-19 safety precautions. All riders must read and sign below. The signed forms will be collected in advance via email or when you arrive for your entry packets.
2. Do not come if you are feeling sick or running a temperature. This applies to Riders, Coaches Rider assistants, volunteers and officials. Each rider is allowed one person as an assistant or coach. No general spectators.
3. Maintain a minimum of 6 ft. from all others except if they already live in the same household.
4. A 6-foot barrier will be erected between the riders and the scoring official in the entry booth.
5. Masks will be required when individuals are within 6 feet of each. Riders mounted on their horses will not be required to wear masks. Only people in the same household will be allowed to be within 6 feet of the rider at their trailer without masks.
6. Completed test forms will be placed in a cloth bag to be transferred to the scoring booth. After the information is collected and posted, the tests will remain there until the riders pick them up after their final class scores have been posted.
7. Scorers will use hand sanitizer frequently while scoring tests. Scored tests will be placed in 1-gallon plastic bags and placed with ribbons on the wall to the left of the entry booth door.
8. Since several riders may be warming up at the same time, one extra area will be set up for the warm-up rides if the designated warmup becomes crowded. This will allow for extra space for those riders with coaches. The Ring Steward will be present to monitor the number of horses in the warm-up and ask riders and coaches to move to a different warmup area if necessary.
9. Riders will be asked to leave the grounds as soon as possible after all their tests. Intro Level Prizes will be handed out before Speed Rounds. In the case of multiple horses trailering together, riders will be asked to vacate the grounds as close as possible to the last scheduled ride time.
10. Hand washing or sanitation stations will be available at the Front Gate and in the Restrooms. Sanitizer will be available for the judge and scribe as well as at the entry /scoring booth so that handling of tests with unsanitized hands are minimized.
11. The Chuckwagon will be taken out of service entirely. All food and beverages must be brought in from offsite.
12. Participants who do not follow the guidelines will be asked to leave the grounds.
13. The restroom will have the middle stall marked "out of order" to allow only two people to use it at once. A sign on the door will indicate that only two people may be inside at one time.
14. All obstacles touched by riders during EOH and Speed rounds must be sanitized between each rider.
